<u>APPROVAL OF MINUTES:</u> The minutes and staff report from the January 19, 2009 watershed council meeting were approved via consensus with a motion from Dave Russel and a second from Dave Archambault.

GENERAL DISCUSSION AND PUBLIC INPUT:

- Richard Chasm and David Parker: They both brought up the issue that their fishermen friends complained about
 the fact there are so many salmon in the river yet so few are fin-clipped (keepers). A discussion followed regarding
 ODFW and the agency fishing regulations for the Umpqua. Stan Petrowski recommended that Tim Walters of
 ODFW address this topic at a future council meeting.
- Sandy Lyon attended the recent "State of the Beaver" conference and found it to be awesome, with an excellent slate of speakers. Kudos to Lois and Leonard Houston and to Stan for a great workshop.

 M.A. Hansen thanked the volunteers who helped out, Sandy, Terry, et.al.

PRESIDENT'S REPORT: Stan Petrowski

- Beaver Conference: There were attendees from 12 western states. Of the many fine presenters, one was from Norway and one was from the Penobscot Indian Nation in Maine. The support at the conference center from the Umpqua Tribe was outstanding. The event organizers used the lamprey conference as a guide for planning this workshop. Stan has been getting emails from folks in England who want to witness what we are doing here on the Umpqua.
 - David Parker asked, "Where can I get beavers for my place?" They are not presently available.
- Bill Rice gave notice that he is retiring from the PUR board. Bob is getting a plaque made to honor Bill. There are several vacancies on the board to fill. The board members should strive to fill those slots.
- The Umpqua Fisheries Enhancement Derby banquet and auction was well attended. Dave Loomis noted that there were 486 people in attendance and the derby raised about \$119,000 gross, about the same as last year.
- The Umpqua Watersheds banquet was held last Saturday at the fairgrounds. Stan received the "Conservationist of the Year" award at the event. There were fourteen PUR members in attendance.
- The use of committees to hammer out issues was a topic of discussion at the last education committee meeting. Stan emphasized in the strongest terms that the use of committees was not meant to exclude anyone from speaking up or as a way to circumvent consensus, but is a forum for serious, open discussions about issues. This provides a more efficient and effective way to utilize limited board members' time at the monthly council meetings.

STAFF REPORT:

- Bob Kinyon, Coordinator:
 - Walking tour of 2.5 miles of Big Creek in Smith River with Sam Moyers, Brian Swift and Matt Ruwaldt. Sam installed the structures in the lower portion 9 years ago and the upper portion 6 years ago. This is a great learning lab for habitat maturity. We try to walk this stretch every 3 years to note changes over time.
 - Attended WC meeting at ODFW conference room.
 - Met with the Executive Committee to discuss my 2009 performance at Karen's Coffee Cup after the WC meeting.
 - Facilitated the first planning meeting for W. Fork Smith River instream log and boulder placement with 11 stakeholders at the Roseburg Resources office in Reedsport. The BLM, ODFW, RR Co, SRWC and PUR were represented. Coos Bay BLM subsequently allocated \$125K in seed money to start the project.
 - Gave a 1½ hour presentation to members of the Bear Creek and other Rogue Basin watershed council members. They wanted to hear about successes and challenges we have faced on the Umpqua over the past 15 years. They were especially interested in how PUR gets more funding and work accomplished than eight watershed councils on the Rogue put together.

- With Sandy, met with Tom Williams from Umpqua Research in Myrtle Creek. We discussed monitoring of all types. Tom wants to get involved with council activities and observe some of our monitoring.
- Visited with Craig Reed, a News-Review reporter, about PUR restoration projects funded by the Umpqua Fisheries Enhancement Derby.
- Conducted a staff meeting on January 25th. Emphasis was on finding a strategy to accomplish project development and grant writing over the next couple of months. Workload demands are increasing on all the staff
- Generated an attendee list for the Derby dinner and banquet.
- Scheduled several committee meetings using the doodle.com site.
- Signed two grants from ODFW to be administered by PUR for the Rock Creek fishway construction. One is a fish passage grant and the other is a screening grant. Funding amount is \$75K for each.
- Spent one day in the field doing implementation monitoring of completed projects. Took monitoring photos of Huntley Cr. instream; Honey Cr. instream and culvert; and Susan Cr. instream, all on the North Umpqua. Also visited Quarry Cr. culvert in the Olalla/Lookingglass watershed and Manzanita Creek culvert, a tributary to Union Creek that flows into Cow Creek near Riddle.
- PUR is a team member on a Pacific Rivers Council-hosted restoration project on Canton Creek, a tributary to Steamboat Creek.
- Worked with Terry on 3 OWEB final reports that are due the end of March.
- Assisted Debbie with resolving a funding issue between Cardinal Services and OWEB fiscal.
- Met with Terry, Dan Jenkins and Fabian Carr to discuss roles and responsibilities for upcoming collaborative projects.
- Received a call from Courtney Shaff at OWEB who said the agency will provide mileage reimbursement for PUR for two trips to Smith River to assist with council development.
- Attended "State of the Beaver" conference on Wednesday and Friday.
- Wrote up draft final report for OWEB grant "Fish Passage 2006.
- Attended education and events committee meetings
- Worked with a logger, John Duncan and Coos Bay BLM staff to fund log moving for WFSR
- Met with Kevin O'Brien, Illinois Valley WC coordinator, at PUR with staff to discuss TAC and other issues.
- Worked with Terry, Matt and Brian to assign project leads and assistants to upcoming projects.
- Discussed with Scott Lamb at Lemolo Lake the opportunity for PUR to administer tui chub trap netting funding for the 2010 project.
- Attended Paul Heberling's retirement luncheon at Kowloons.

- Packaged and shipped all equipment to DEQ that requires NIST certification. This certifies the accuracy of all temperature equipment.
- Performed South Umpqua monitoring run
- Attended all three days of the Beaver Conference, helped out with computers, projectors and getting everyone's PowerPoints ready to go
- Diane Phillips and I did Elk Creek/Tiller monitoring run
- Attended Paul Heberling's retirement celebration lunch

- Attended field and WF Smith River meetings with Terry and Bob (see their reports for details)
- Toured Smith River with Brian and Ben Herr to discuss potential projects

<u>PRESENTATION(S)</u>: Bruce Miller, fisheries research biologist, ODFW – Charleston: "Fish monitoring in West Fork Smith River: how fish production appears linked to summer and winter rearing habitats".

Bruce presented slides and talked about the "Salmon Life Cycle Monitoring Program" he has been involved with for the past 10 years. He spoke about the population trends of coho and steelhead; the carrying capacity of the sub-basin; and the physical characteristics of the stream itself. He finished with a discussion of the potential benefits of the upcoming instream restoration project to introduce large woody debris to the stream. Bruce indicated that ODFW intends to continue monitoring fish populations in the West Fork for years to come.

COMMITTEE REPORTS:

- Technical Advisory (TAC) Committee: Terry Burleson
 - Terry led a discussion about the role of the TAC. It has morphed into a "project review committee" over time and most of the committee member's time is spent looking at the technical feasibility of potential restoration projects. She will work on a proposal, with the committee, defining what the TAC will do in the future and present that to the board at a future watershed council meeting.
- Events Committee: Richard Chasm
 - Richard has done considerable research on the annual *Umpqua River Clean Up* (UR Cup). He presented some suggestions about how to kick off the event in year 1 for PUR. He talked about developing flyers for the event; having regional coordinators; and working with the county road crew to utilize heavy equipment or county crews to remove spoils from the riverbanks along with individual volunteers. The idea of a "time exchange" was also batted around during the discussion.
- Education Committee: Stanley Petrowski
 - "Contingent on Nancy Geyer's acceptance, hire her for the O/E Program Manager slot and set her on a course to develop the PUR-version of the Master Watershed Stewardship course. Re-evaluate the program after one year. If it is working well, continue. If not, pursue the option of advertising for the position." The above is a motion put forth by Stan as the chairperson of the committee. Richard Chasm provided a second and the motion passed without objection. There was discussion regarding job description; time available to work on the project; funding amount and source to pay the program manager and for developing the Master Watershed Stewardship class. Existing title III outreach funding at Elk Creek Watershed Council was also discussed as a potential funding source, but Lee Russell indicated the funding was not designated for this type of training.
